Poraus Usun Iseis Ren Aramasen/Aninis

Q1: Ngang use sinei ika are ifa usun ai uwa aramas ngeni ewe semirit ina ii a kan non mochenin ren tumunun foster iwe met upwene fori?

A1: Ika pwe en kose kan sinei ifa usun meni eom kopwene aramas ngeni emon semirit, iwe kose mochen kori ewe chon sineieochu kuuten aramasen. Ir repwene tongeni anisuk eom kopwe weweiti ifa usun eom aramas ngeni.

Q2: Ngang uwa kan mochen ai upwene emon nenien angei aninisin iseisenong ren ewe semirit. Meta upwene mochen fori?

A2: Ren eom kopwe tumunu pwe ew imw mi tumun me pwan eochuno ren iseisenongen emon semirit, ekkewe mi tapweto repwene kan fofori:

- Emon me emon aramas ier 18 me pwan nap seni ra nonom non ewe imw repwe kan passeni ew chekin porauser non unusen fonu.
- Emon caseworker epwene awasano ew apoputan churiin imw ren an epwe tumunu pwe ewe pechakunen, tumunun me pwan menaweochun ren ewe semirit.
- Ew Kaeon Imw epwene awasino ren ar repwe checheki an emon me emon chon tumun kena tongeni ar repwe tori mochenin ren ewe semirit kewe.

Q3: Emon chon nom non imw a wor wuuruwon an atai annuk. Meta ina wewen pwe ngang usapw kan apunguno?

A3: Wuuruwon katan annuk epwene kan chekifichi ren ar repwe finata tumunun ewe semirit. Ekkoch katan annuk kena ra kan fori nafengawfochenon, nge pwan ekkoch ra kan tongeni ekkiekieno. Ei epwene kan fis seni non nenengenin mettoch kena usun chok: ifa tamenon fansoun a passeno, ierumewe non ewe fansoun ren ewe atipis, usun menauwon ikenai, me pwan ekkoch sakkun kena repwene nenengeni.

Q4: Ika pwe ngang uwa nonom nukun state, met ngang upwene chuen finita ren iseisenong?

A4: Mi wor ew foro a wor non ina epwe mut ngeni aramasen kena ina ir ra nonom non pwan ew state ren ar repwe ekkieki ngenir ren iseisenong. Ei a kan aiita ngeni ewe Interstate Compact on the Placement of Children, me pwan a kan tongeni awewe non tichikin seni noun ewe semirit we social worker a asain ngeni.

Q5: Ika pwe a apunguno ren iseisenong me pwan ewe semirit a etto an epwene nonom rei, meta aninis a kan kawor?

A5: Mei wor sakopaten aninis kena ra kawor ren aramasen kena ina ir ra kan apunguno ren ar repwe angei emon semirit non ar tumun. Ren eom kopwe kaeo napenon usun aninis kena ren chon tumun kena ir aramasen, churi: <https://www.dcyf.wa.gov/services/foster-parenting/kinship-caregivers>

- Aramaser kena ra tongeni ar repwene sam me in foster ir mi laisen, me pwan nupwen ei esapw kan fofori ren ar repwe angei emon semirit iseisenong non eom tumun, mi wor ew namoten aninisin moni ren eom kopwene kan laisen. Ren emon sam me inen foster mi laisen, en ka naf ren momosefanin tumunun foster ina a kan iteiten tekia seni ekkoch aninisin moni mi kawor ika pwe en kose kan laisen.
- Aramasen kena ir ra kan fini pwe resapw kan emon sam me inen foster mi laisen ra tongeni aeoeo ren Temporary Assistance to Needy Families (Mwochomwochen Aninisin Mochenin Family Kena, TANF) ren ar repwe atotongeni aninisin moni kena me pwan namoten aninis kena.
- Foster semirit kena repwene naf ren ewe "Passport to College Promise Scholarship" program ika pwe ir ra tori ekkoch tetenin kena. Emon aramasen mi laisen ina a kan ewe iseisfocheno seni non emon chon tumununo epwene naf ren ew momo seni non an Washington we Relative Guardianship Assistance Program (Programen Aninisin Tumun seni Aramasen, R-GAP).

Q6: Ngang use kan tongeni ai upwe emon chon iseisenong. Meta mi wor ekkena pwan ekkoch sakkun ngang upwe tongeni aninis?

A6: Mei wor chomong sakkun kena aramasen kena repwene tongeni awora aninis ngeni emon semirit ika sam me in ika pwe en kose kan tongeni eom kopwe emon finin iseisenong. Kose mochen kopwe kan ekkieki ika pwe en ka tongeni:

- Awora wawa ren ewe semirit ren an epwe churi semen me inen kewe, pwin me mongean kena ika napenon an family.
- Awora mwochen asoso ren semen me inen foster kena ika pwan ekkoch aramsen kena ra tumunu ewe semirit.
- Anisi ne awora aporausen menawen ika wuuruwon safean family ren ewe semirit.
- Anisi ne awora sasingen family kena pwe sipwe kan fori ew puuken sasing ren ewe semirit, an ewe at/nengin family, ika ewe napenon family.
