 - We sent emails for recruitment on these groups. I know we send a lot of emails and we're open to feedback on how to share information with you.

 - The emails are too long, and separating out the recording and notes and I don't realize the other information.
 - I find the tables not helpful and throws me off. The organization of the emails could be worked on.
 - To me the emails don't cause me an issue, and color coded and different font could help.

- Unsung Heroes update
 - We went through all the applications, and made our recommendations and the ceremony is Feb 23, 2024, in Olympia.
- Provider Supports update
 - We had our last meeting in December. We learned that 4% of intake calls are founded. Why are we spending so much time on these intake calls and waiting on feedback? We also learned about community café, early learning language access, getting sign language added, background check updates (2 years vs 5 years and expressed concerns), health care plan for childcare workers. Next meeting in is April.
- Children's Health Insurance Program (CHIP) update
 - Housing, jobs, mental health, childcare issues, and each county got to elect our issues and our county decided on childcare. No one else on the committee had experience in childcare and I was the only one, so I'm helping to set goals for providers in the area.
- Governor's poverty reduction work group update (website)
 - Met with legislators and meeting basic needs and transforming the cash assistance program.

- Spokane and Stevens County don't have a host for Parents for Parents and Health and Justice Alliance is stepping in. I will be a host parent and guiding parents through the child welfare system.
- What about a landing page that lists the upcoming events and opportunities with links for sign up.
 - That is a great idea. We can add those opportunities to the webpage when they are open.
- I'm part of <u>People's First</u> an advocacy group for people intellectual disabilities and Pierce and King County are selected to be part of the conference. I'm a big advocate for a bill "<u>Nothing Without Us</u>- HB1566" and working to get it pushed through legislative session.
 - I'm part of <u>Washington State Community Connectors</u> (WCCC) serving families with children with mental and behavioral health.
- DCYF Updates
 - We are developing a Community Engagement framework with a consulting firm the Athena group.
 - LGBTQIA+ advisory group we are figuring out what the scope of that group with be and figuring out to best support our youth and LGBTQIA+ representation.
 - Language Access Plan group is to represent the procedures, processes, and best practices to help DCYF promote language-based inclusion and enhance our capacity to serve families with Limited English Proficiency (LEP).

- HB 5793- Workgroup committee worked on this and became effective 2022 and it states that agencies need to pay for their lived experiences. So why did this not get funded?
 - This is a good policy related question. This presentation is based on DCYF requests that are presented to the Governor and he then creates his proposed budget, which is what we are discussing.
 - Right now we were talking about the disconnect between a bill and the funding around these topics.
- Question on HB 2007, what are the time limits until is it approved?
 - It's still under consideration and needs to be signed by March 7
- If something wasn't included in the governor's budget does that mean that it can't be included in the legislature's final budget?
 - No, there's always opportunity to comment and advocate and let your legislators know what you think.
- How can I learn more about the legislature?
 - Legislative Information Center (tutorials and bill tracking)
 - Session cutoff calendar.
- Who is responsible for pushing back against the governor when they don't follow through within the agency?
 - It comes from the community, and I understand that doesn't feel good (lack of accountability).
 - It feels dismissive of him to sign something and not provide the funding.
 - We are the folks who use these services, yet when it comes to advocating for our needs it feels like it doesn't matter and there isn't accountability on their end and they don't know what it feels like to be us. Government agencies need to listen to the people it serves, be prepared to be held accountable.
 - I agree with you, the state agencies serve as the elected officials and they need us for the vote.
 - We're just talking about the system protecting the system, it is doing exactly what it's designed to do. He (governor) is doing exact what he signed on to do, and it's

- I feel that the ones near me in Pierce County don't do much to get the word out on what they provide for support or services.
- There are over about 100 FRCs in the state of WA, but one of the challenges right now is there isn't a FRC list.
- o I just googled and didn't find any in my area of south Seattle.
- o The original was the Cynthia Green building in Skyway.
- I lived in the Bethel and Franklin Pierce. I was well rooted in the community and never knew about this service until I recently started working at the Health Department.
- o FRC Spokane County- 130 S Arthur St.
- That would depend on the definition of FRC, does it mean where to get help? Then yes I know of them.
- Other school districts resources are cut in half.
- o Is there just one centralized system or is it a broad description?
 - It can be stand alone or connected to other organizations (health department), it's a broad term.
- In Pierce County, the FRCs are specifically connected with the health department. Women, Infants and Children (WIC), the program for families with young children for nutritional supports. Many others are connected to school districts. In Vancouver, for example, all the schools (elementary - I think) have a Family Resource Center.
- If you or someone you know has gone to an FRC, what was that experience like? What went well and what would you have liked to be different?
 - No responses
- What do you think the benefit is, or could be, of having an FRC in the community?
 - I feel like we need mental health support in place before youth are placed in foster care.
 - One stop shop for help with needs.
 - A place to go get questions answered. A safe place and possibly a place for food or resources (medicine pick up).
- How could FRCs make themselves welcoming for people with different backgrounds and ages?
 - It would be nice to have a list of these community resources.
 And we could become allies and help to educate our own communities and other organizations as a way spread the word.

Sounds like they have resources that we don't really know

- We discussed the disconnect in FRC, the need for FRC to be attached to income eligibility, we discussed schools and trust rebuilding especially when child welfare was is involved.
- We talked about mobile services, fairs that pop up in the county, and rural access with limited access. Resource ambassadors and meeting family's needs proactively and creating relationships that make family's feel safe asking for support and funding.
- That reminds me that there are a bunch of Facebook parent groups/mom groups that folks go to for help/resources. I like Heather's idea for DCFY having something similar.
- What should DCYF be considering as we explore expansion of FRCs? How would/should parents be involved in next steps?
 - DCYF could change their image and have more of a rapport with communities and list FRCs on the DCYF website.
 - o If I saw a FRC I would not see this as a DCYF centered resource.
 - FRCs can bridge entrenched silos. This opportunity needs to be addressed in the planning stages.
 - o Define what an FRC is, the mission and vision.
 - A place to go for mail, showers, laundry, housing or shelter or resources such as socks and blankets. Also help completing applications like childcare, DSHS, SSI (etc.).
 - Parents should be at planning and implanting table.
 - On site nurses, mental health personal and school personal navigator.
 - DCYF has preventative measures yet there's so much stigma around child welfare and I agree there needs to be rebranding/ rebuilding with the community.
 - My daughter has anxiety and makes unsafe decisions. I called her psychologist when she was emotional irregulated and they asked if she had a plan. Families should not feel DCYF is the last option, it should also be preventive option.
 - I called CPS for resources because children are in abusive environment and was told I should handle it.

2025-2029 Child and Family Services Plan

- From your perspective, what has worked well with DCYF's initial meeting with families?
 - O Child Protective Services (CPS) entered my life when I was 14 and it was not positive and I had a visit from CPS recently and it was slightly better experience, although the tone of the recent meeting was a bit threatening. "If you can't meet with us, we will go to daughter's school."
 - 1st contact was a phone call when a CPS investigator was in the driveway. He was rude and threatening, showed up at lunchtime (super busy part of the day), demanded to speak to each of us separately while we had a crowd of children here. Then (at final report time) made further allegations about "use of cameras" (when we don't even have cameras) so, he basically made up this part.
 - O What happens if a family does not comply with an intake?
 - I'm uncertain and I can get a response from the program manager.
 - I've had 3 different interactions, first two interactions were belittling and traumatizing and third time was a different experience. The casework was a phenomenal and nice man and when talked about my child his face lit up.
- Is there any specific things DCYF should have done better?
 - Not take situations out of context. Make sure families know you're there to help.
 - Don't be abrasive and expect the worst. Just because there was a report doesn't make it true.

- I admit I wasn't being a good parent and was under the influence. The first two interactions I was treated like a criminal and the third casework treated me normally and made it about the children.
- They refused to give breast milk to my baby, and he was covered in dried vomit.
- Strength- based is a good approach. I've had 3 unwanted knocks at my door, and it was a rude and judgmental experience. The last time there was more accepting and positive.
- CPS has a "police" reputation and they need a new approach, but they'll have to build this new reputation over time (it's going to take a generation or 2 at least to repair this...).
- As a foster parent and Court Appointed Special Advocate (CASA), I'm concerned DCYF isn't assessing safety concerns. It took 25 calls before my children were removed in a home where another child died. It's unacceptable.
- I have a different experience being foster/adoptive parent and having social worker friends. It's a tough job and is there consideration for the mental approach aspect for case workers?
 - Workforce is a listed goal, and we did hire a staff support position. In the governor's budget there is also a peer support system for social workers. Part of this development process is to meet with leadership across different programs for feedback.
- Each encounter with CPS left me in shock. When you asked how can we do better, let's start with supporting families before it escalates. Listen to what we're telling you. If I get so much judgment for my past, there feels like a bias against me. We also need to have lived experts at the table.
- Clarifying question is this self-reported, how is this determined?
 - Both, interviews from social workers, case works and parents.
- Are the services meeting families' needs?
 - Where is Indian Child Welfare (ICW) housed? How to bridge silos?
 - We'll be talking with Tribal Policy Advisory Council (TPAC) and working on getting alignment.

o Yes

- When my child was taken, they didn't ask about their needs (medically, religious, culturally).
 - Someone mentioned Safe Care, did you use that?
 - I know of it, but it also wasn't accessible. Those things cost money (railings and covers) and having my older child assisting me is necessary. Somethings were overly critical and don't work for my family's needs.
- As a foster parent you we must take a foster child to a doctor within 3 days. We must do what the parents want, so there is communication happening.
 - It isn't always shared and communicated. We don't know where they are going and what's happening.
 - And I (as a foster parent) must give my contact number to the parent.
 - This is helpful for me to investigate this feedback further as a regional and systemic issue.
- Universal childcare will keep families together.
- A parent support call or intake with a foster child should happen.
 - Parent for Parent group is that type of resource.
 - 4250: Placement Out-of-Home and Conditions for Return Home.
- Adoption support: training, parent workshops, kid peer groups.
- Most families are finding themselves in crisis. Help getting people's mental health under control is needed.
- I know there are CASAs and advocates for the kids, but is there a role for someone who advocates for & supports parents?
- Respite care without judgement! Sometimes a man, especially a man with kids with disabilities needs help and a break, not judgement.
- Not allowing a daycare to kick a child out.
- How well is DCYF providing services that take into account cultural and developmental needs?
 - Very poorly

- Indian Child Welfare (ICW) is the gold standard. Instead of reducing expand to all children regardless of obvious cultural differences or citizenship status.
- How have caseworkers engaged you or your child in case planning? What worked well?
 - Challenges with the way caseworkers talk to parents and transparency around communication. How can we make sure the process is fulfilled in supporting families, foster parents, adopted children (who have high needs)?
 - Everyone wants what's best for children (both foster and birth parents) so when is the opportunity for them to come together? I have 3 generations of children lost (in the system).
 - I went to my attorney and wrote my own parenting plan even when the judge ordered for my children's return.
 - My caseworkers have never engaged me in service or planning my case.
- What is your experience with caseworker visits? Were there locations or times worked better for you?
 - I am the extended family, so every time a worker changes, I
 have to redevelop my status and prove my worth. I get
 meetings sometimes and then I get nothing and then suddenly
 there is a meeting I'm invited but not included.
 - They were last minute and often would make my husband miss work. He eventually couldn't keep working than they were mad at him for not working.
- How do you think we should better partner with parents and caregivers?
 What does strong engagement look like to you?
 - Have parents and caregivers meet each other in the DCYF (office) to break down barriers.
- I will follow up with your feedback with leadership and revisit this topic in a future meeting.
 - o Does anyone at the leadership table have lived experience?
 - I don't know and will ask.
