# **DCYF's Early Learning Division Updates**

# 2025 Child Care Complex Needs Fund Now Open

DCYF is pleased to announce that the 2025 Child Care Complex Needs Fund application is now open. Eligible licensed, certified, and certified-for-payment-only child care providers and eligible license-exempt Family, Friend and Neighbor (FFN) providers can apply for the Child Care Complex Needs Fund in the <a href="WA Compass Provider Portal">WA Compass Provider Portal</a>.

#### What Can the Fund Be Used For?

- Adding staff members to support children with complex needs, increasing staff hours to support children with complex needs, and up to a \$5,000 hiring bonus for new staff that support children with complex needs.
- Facility improvements to comply with ADA accessibility requirements.
- Therapeutic services. Therapeutic services mean services offered by skilled professionals, that focus on curative, rehabilitative, preventative or healing practices.
- Supportive and adaptive materials and equipment.

# How Much Funding Can a Provider Request?

- Eligible licensed, certified, and certified for payment only child care providers can request between \$5,000 and \$50,000.
- Eligible Family, Friend, and Neighbor (FFN) providers can request between \$100 and \$2,000.

DCYF strongly encourages all providers to utilize our technical assistance partners. Individual technical assistance is available and includes guidance on preparing for and accessing the application, in addition to advice on saving receipts and documentation. Providers may access technical assistance in their preferred language and by telephone, internet, or inperson. ### Early Achievers Updates – Timeline and Quality Level Finalization

Exciting news! In spring 2025, DCYF will be implementing two changes to Early Achievers to support participants whose timelines were impacted by the COVID-19 pandemic pause:

- Timeline Adjustments: DCYF will be doing a one-time extension of Quality Level due dates to be based on when a site completed its Program Profile. Participants will see this change reflected in their Early Achievers profile in MERIT.
- Quality Level Finalization: Early Achievers participants can finalize a Quality Level at any time in MERIT. If they do not finalize a Quality Level by the due date, MERIT will do this on their behalf.

## Early Achievers Updates – Program Profile

DCYF is happy to share the revised Program Profile, made to better support early learning providers, families, and coaches. This update comes from feedback from many sources, including the early adopters survey and direct comments from users.

### What's New?

- Easier Family Surveys: Families can now fill out surveys using a link or QR code, so teachers and directors don't have to enter email addresses one by one.
- Self-Check Tool: Program leaders can now review their practices at the start of the three-year cycle to see where they are and where they might want help.
- New Report Design: The reports now look better and make it easier to see strengths and areas for growth.

### **Access and Living Wage Proviso Status Update**

The Washington State Legislature has tasked DCYF to submit an implementation plan to expand access to Washington's mixed delivery child care system (ESSB <u>5950</u> Section 229(31)).

The Early Care and Education Access and Living Wage Proviso Implementation Plan will outline DCYF's plan to lower family contributions to high-quality early care and education at no more than 7% of a family's income (a sustainable amount for a family) and uplift the early care and education workforce with a living wage and benefits.

DCYF will submit the Implementation Plan by June 30, 2025. Because the full implementation plan is not available until after the 2025 Legislative session, DCYF has prepared a <u>Status Update Report</u> on the plan's progress.

## Prospective and Enrollment Based Pay for Child Care Subsidy – Feedback Next Steps

In October, Matt Judge and Jason Ramynke presented to ELAC on Prospective and Enrollment Based Payment for Child Care Subsidy, specifically the CCDF requirements and options for implementation. During their presentation they asked attendees for feedback on the following areas:

- Paying one provider per child at a time
- Verifying a child's enrollment and other eligibility requirements
- Timeframe of no attendance before closing authorizations
- Monthly vs. daily rates

Please see the appendix which includes all the feedback received and the DCYF responses. DCYF will use this feedback in development of policies with implementation and provide updates and opportunity for feedback through that process.

# Office of Innovation, Alignment and Accountability

OIAA has convened a report team comprised of DCYF staff who will use their subject matter expertise to review the 2025 FSKA evaluation legislative report. We held our scoping meeting in September 2024 and submitted the scoping document according to DCYF's Government Affairs process. OIAA will be reaching out to this team in spring of 2025 to begin reviewing the draft report, which is due to the legislature on September 15<sup>th</sup>, 2025. We continue conducting supplemental analyses (e.g., child care continuity), as well as updating some of the existing analyses with 2024 data (e.g., provider churn) for the FSKA evaluation. # **Rule Making Update – Recently Completed Rules**

Capacity Waivers for Family Home Providers and Training Requirements
DCYF Licensing Division filed WSR 25-01-087 to amend the Capacity waivers for family home providers and training requirements rules. These amended rules, WACs 110-300-0106 and 110-301-0106, are needed to allow a three-month timeframe to obtain training requirements for child care and early learning programs, specifically first aid and CPR certifications. The

amended WAC 110-300-0358 is needed to issue capacity waivers to allow no more than 16 children in a family home child care program, only after they meet all other requirements. It also updated the emergency preparedness requirements and now requires better coordination between DCYF, child care providers, and local building authorities. The new rules go into effect Jan. 13, 2025.

#### Note:

WAC 110-300-0331, WAC 110-301-0331, and WAC 110-302-0331 were previously filed with the above WACs. These WACs will now be filed separately in January 2025.

Fall 2024 WaKIDS data is now live on the Washington State Report Card. During the **2024-25** school year, **53.6%** of all **70,343** Kindergartners met expectations in all 6 domains of kindergarten readiness.

# **Department of Social and Health Services (DSHS)**

 Food and cash benefits stolen by card skimming, card cloning or other fraudulent methods after Dec. 20 can no longer be replaced. SNAP replacement was a lastminute deletion from H.R. Bill 10545. DSHS is still committed to protecting benefits and supporting those affected by fraud, and has made successful investments to protect its clients in this regard.



Replacement of Stolen Benefits Is En

- As of Jan. 1, 2025, Washington state's minimum wage increased to \$16.66 per hour.
- Also effective Jan. 1, the maximum Diversion Cash Assistance benefit increased from \$1,250 to \$2,000 in a 12-month period. The increase in the DCA payment makes diversion a more practical option for families in transition. Some families don't need a monthly TANF grant but have enough income to meet ongoing needs. Such families could opt to receive a one-time DCA payment to pay rent, access transportation to work, or keep current on utilities without using their TANF months, assigning their child support rights or having to comply with WorkFirst requirements.

Dear interested parties and community partners,

Congress passed the <u>Continuing Appropriations and Extensions Act</u>, 2025, on Sept. 26, 2024, which extended the replacements authorized in the <u>Consolidated Appropriations Act</u>, 2023. The act required states to replace food benefits stolen between Oct. 1, 2022, and Dec. 20, 2024, via card skimming, card cloning and other similar, fraudulent methods.

As of today's date, Congress did not extend the date to replace these benefits. Based on current guidance, food benefits stolen on or after Dec. 21, 2024, cannot be replaced.

Cash replacements will also end, as rules authorized under <u>ESSB 5950</u> to replace Temporary Assistance for Needy Families, State Family Assistance, Pregnant Women's Assistance, Refugee Cash Assistance and Aged, Blind or Disabled cash benefits stolen July 1, 2024, or later mirror the end date for food replacements.

The department will deny any claims for benefits that are stolen on or after Dec. 21, 2024. This change does not affect claims for benefits stolen on or before Dec. 20, 2024; we will continue to process these claims if reported within 30 days of discovery, even if the date of discovery is after Dec. 20, 2024.

Dear Respected Tribal Leaders,

We have great news. The Community Services Division is increasing the maximum Diversion Cash Assistance benefit from \$1,250 to \$2,000, effective Jan. 1, 2025. The costs of everyday living needs such as housing, transportation and employment-related expenses have grown significantly since the DCA program was created. The changes to <a href="RCW 74.08A.210">RCW 74.08A.210</a> "Diversion program – Emergency assistance" increases the DCA maximum cash benefit to \$2,000 to better meet a family's true expenses for one month.

DCA provides one month of assistance in a 12-month period to families that meet income and resource limits for the Temporary Assistance for Needy Families program but only need short-term help. To qualify for DCA, families must show how they will meet their basic living needs for the following 12 months. Families are often eligible for the program when they experience a gap in employment and have a new job offer or start working but have not yet received a paycheck. As an alternative to TANF, the DCA program assists families in meeting basic needs such as child care, housing, transportation and other expenses to get a job or stay employed. These payments are made directly to vendors whenever possible, with the actual payment continuing to be based on the family's needs.
