DCYF Community Child Care Forums

Early Learning Grants

- Early Achievers Needs-Based Grant:
 - Fiscal Year 2024: Distributed \$1.5 million
 - 1,500 providers received a FY24 Needs-Based Grant
 - Improved application reduced processing time while allowing maximum spending flexibility for providers.
 - Fiscal Year 2025 Needs-Based Grant application will open in the first week of July
 2024
- Child Care Complex Needs Fund:
 - o Fiscal Year 2024: Distributed \$9.9 million
 - 162 providers received a FY24 Child Care Complex Needs Fund award.

- o Fiscal Year 2025 Child Care Complex Needs Fund will open in Fall 2024
- ECEAP Complex Needs Fund:
- o Fiscal Year 2025: Awarded \$7.8 million
 - 47 ECEAP Contractors were approved for funding, which will go into contracts starting July 1
- Fiscal Year 2026: RFA should open late in 2024.

• Early Childhood Equity Grant:

- Fiscal Year 2024-2025: Awarded \$9.7 million, using the majority of funding for the entire biennium (FY24 and FY25)
 - 179 providers were approved for funding, and funding will be distributed in the coming weeks (late June and early July)
 - DCYF added a required special technical assistance session for grantees to ensure they are set up to successfully manage their grant award, and that they fully understand the terms and conditions of the grant.
- Fiscal Year 2026: DCYF plans to open the next Early Childhood Equity Grant application in early spring of 2025, for payments to go out in summer of 2025.
