7:15 – 8:20	Parent/Caregiver Supports Panel GOAL/OUTCOME: PAG members will hear from a 5 programs or teams that directly or indirectly support parents and caregivers.  • Help Me Grow:  • Sarah Holdener serves as DCYF's Family & Community Navigation Administrator. In this role she focuses on strategic planning and implementation of Help Me Grow Washington, a systems approach weaving together state and community systems, providers, and resources to offer a full spectrum of supports to all families in Washington state with young children. Sarah liaises with state agencies, coordinates federal and state funding to the Help Me Grow state affiliate, and promotes cross-sector integration to improve system outcomes for children and families.  • When working with families, we describe Help Me Grow as a free service that connects parents and caregivers to resources in their community. Whether it's understanding your child's development, food assistance resources, free or low-cost health insurance, or pregnancy and parenting resources, we are here to help. Depending on where you live, our local and Help Me Grow statewide hotlines are ready to support you and your family. This webpage provides more detail for those that want a deeper look  • April Thompson - Developmental Disabilities (DD) Program Manager and DD/Mental Health Program Consultant Supervisor.  • My team and I support DCYF's Child Welfare Division with resources, trainings, DDA eligibility requests, collaborating with state and community partners and more. My official role is Developmental Disabilities Program Manager, and I do a bit of systems work between DCYF and DDA, while supporting my team of 6 supervisees. More information about our work can be found on this handout.  • Xyzlora Brownell and Veronica Santangelo - Early Childhood Intervention and treatment services for families and their young children age Birth to 5 who have experienced substantial stress and/or complex trauma. ECLIPSE services are trauma-informed, center-based, intervention and treatment services f		

available to young children and families who interact with multiple systems, including the Department of Children, Youth, and Families (DCYF) child welfare. Children and families that have or are interacting with the DCYF child welfare system are categorically eligible for ECLIPSE services through their enrollment in the Early ECEAP/ECEAP program.

## Paul Davis and Patty King - WiSE

- Wraparound with Intensive Services, or WISe, is an approach to helping children, youth, and their families with intensive mental health care. Services are available in home and community settings and offer a system of care based on the individualized need of the child or youth. WISe is a voluntary service that takes a team approach to support you and your family in meeting your goals. This program is eligbile to children and youth eligible for Medicaid coverage. - Laura Alfani/Jenni Olmstead DCYF Family and Community Support/Strengthening Families Washington/Primary and Community Based Prevention
  - Community-Based prevention programs and partnerships including diaper banks, Family Resource Centers (FRCs), parenting education, family support, perinatal mental health, and more. This team focuses on supporting families and communities through primary and secondary prevention efforts with an emphasis on the <u>Protective</u> <u>Factors Framework</u>.
