#### DCYF Awards Nearly \$3.7M to Early Learning Programs Serving Tribal Children

Over 30 tribal-serving organizations, including 13 tribal nations, are receiving nearly \$3.7 million in funds from the Washington State Department of Children, Youth, and Families (DCYF) to provide early learning, child care, prenatal, and home visiting programs to tribal children.

The awardees include 34 tribes, tribal providers, and tribal-serving organizations, for a requested total of \$3,698,869 in funds. This is the second round of Tribal Early Learning Funds (TELF) provided by DCYF in 2024; a previous round of grant funding was distributed in April for a total of \$2.4 million. ## Rule Making Update – Permanent Rules Licensing – Multi-Licensed Foster Care Family Home and Family Home Child Care Licenses The DCYF Licensing Division filed WSR 24-17-063 to finalize rules that allow a family home to be licensed for both foster care and child care. The anticipated effects are more child care options within communities and increased placement options for children needing foster care. Furthermore, the rules allow for continuity of care which is expected to create more stable experiences for impacted children. The permanent rules take effect September 15, 2024. Working Connections Child Care – Eligibility The DCYF Early Learning Division filed WSR 24-17-059 to finalize rules that expand eligibility to people working in licensed child care centers and licensed family homes, specialty and therapeutic court participants, and undocumented children. This rulemaking also establishes eligibility for families with a parent participating in a state-registered apprenticeship with income less than 85% of the state median income who, within the last year, were approved for Working Connections Child Care. The rules are currently in effect under emergency status.
