

HVSA Overview

- Home Visiting Services Account (HVSA) is the state account through which state-funded home visiting flows
- The HVSA funds approximately 1/3 of home visiting services in Washington through contracts with 49 Local Implementing Agencies (LIAs).



DCYF Funded Home Visiting

- Voluntary, family-centered services offered to expectant parents and families with new babies and young children to support the physical, social and emotional health of the child.
- Prenatal to 5th birthday
- When families receive home-based support:
 - Children are better prepared for school
 - Abuse and neglect are less likely to occur
 - Parent-child bond is stronger



HVSA Goals

- Enhance child development & well-being
- Alleviate effects of poverty & other risk factors
- Reduce the incidence of child abuse and neglect
- Promote school readiness



Funding Terms

Availability: Up to \$40,000 total

Scope: One, possibly two contracts

<u>Contract Term</u>: July 1, 2023 – March 31, 2024



Eligible Organizations

- Local government agencies, including health departments and school districts
- Nonprofit organizations
- Educational institutions, and
- Federally recognized Tribes located in Washington State



Eligible Communities

- Applicants must propose exploration planning for home visiting serving communities within one or more of the following 5 Washington State Counties:
 - Asotin
 - Columbia
 - Garfield
 - Klickitat
 - Skamania



Exploration Planning Goals

- Engage with the community to determine home visiting needs
- Estimate who and how many families will utilize the service
- Identify organizations to collaborate with for successful implementation of home visiting, including host agency, referring partners, service partners
- Determine the home visiting model best suited for the community and family needs
- Anticipate staff needs



Eligible Home Visiting Models to be Considered in Planning

Evidence-based, Research-based, and Promising practices:

- Nurse-Family Partnership (NFP)
- Outreach Doula
- ParentChild+
- Parents as Teachers (PAT)

- Child Parent Psychotherapy (CPP) in-home modality
- Early Head Start Home-Based Program (EHS)
- Early Steps to School Success (ESSS)
- Family Spirit
- Steps Toward Effective Enjoyable Parenting (STEEP)

Populations to be considered for planning must be families prenatal or with children ages 0 through 4 years (prenatal up to a child's fifth birthday).




