## NEW KINSHIP LICENSING STANDARDS

Create a simplified, streamlined process to license kinship caregivers

### **PROJECT GOALS**

- Create and implement NEW Kinship WAC Chapter, Policies and Procedures, ready for public review in December 2024 and effective Summer 2025
- 2. Promote equity by taking steps to address systemic imbalances, which have disproportionately impacted historically excluded communities
- 3. Simplify the Kinship Home Study processes to make it easier to license Kinship Caregivers
- 4. All impacted groups and Tribal partners help create the new Kinship Standards
- 5. All impacted parties and Tribal partners understand the change and are trained effectively
- 6. IT systems support the simplified process

## **UPDATING A HOME STUDY**

When does a Home Study need to be updated?



A Home Study must be updated when:

- Add new kinship child(ren) to a kinship home
- Add adoption requirements for kinship home
- Converting from unlicensed kinship care to a kinship license, including when adding children

The current Home Study form is used for both Community Foster Care and Kinship Home Studies

## **TAKING ACTION**

#### There is no reason to wait to help staff and caregivers!

- First deliverable in the Kinship Licensing Standards project!
- Grounded in National Kinship Standards, DCYF, Tribal and Partner expertise
- New Kinship Home Study Update streamlines and simplifies the process now
- Allows for early feedback to be incorporated into the new Kinship Home Study
- New form is temporary until the new Kinship Licensing Standards are Effective Summer '25

## What's Different?

- New Home Study Update is aligned with new National Kinship Standards
- Focuses on critical questions that pertain to kinship caregivers and the specific child
- Removes unnecessary questions and requirements

Removed Questions about:

- Community (general) Foster License specific requirements
- Required historical information that doesn't change
- Data points for indicators previously collected
- Streamlined the form and refined questions

### What's the Same

- 1. Same reasons why an update to a Home Study is needed
  - Add new kinship child(ren) to a kinship home
  - Add adoption requirements for kinship home
  - Converting from unlicensed kinship care to a kinship license, including when adding children
- 2. Still completing form in WA CAP by DCYF Licensing Staff, Child Placing Agencies (CPAs), and Tribal CPAs
- 3. Form will continue to be reviewed by Child Welfare, Adoption, Courts and other Staff
- 4. Caregivers will still be able to review the resulting report



## **Kinship Home Study Update**

The overall process is unchanged, only now it is simpler and streamlined



### **KINSHIP HOME STUDY UPDATE FORM #1**

IMPACTED TEAMS: Licensing Division - Assessment Team, CPA's & Tribal CPA's

**EXPECTED RESULTS:** Reduction in time required due to fewer questions and less duplicative work

#### **START: SEPTEMBER 30, 2024**

**WHAT:** Use Kinship Home Study Update Form (DCYF 10-018B) when updating a previously completed Home Study

WHO: DCYF Assessment Staff, CPA & Tribal CPA's WHEN:

- Adding new kinship child(ren) to a licensed kinship home
- Adding adoption requirements for licensed kinship home

### WHO: DCYF Assessment Staff WHEN:

- Converting from unlicensed kinship care to a kinship license
- Adding children to an unlicensed kinship care home

#### STOP: SEPTEMBER 30, 2024

**WHAT:** Stop using form Home Study (DCYF 10-043) for updates to Home Studies for Kinship

WHO: DCYF Assessment Staff, CPA & Tribal CPA's

#### **CONTINUE:**

#### WHAT:

- Using Home Study Form (DCYF 10-043) for
  - New kinship homes
  - New community foster homes
  - Updates to community homes
- Share the report with applicants

WHO: DCYF Assessment Staff, CPA & Tribal CPA's

### If you **COMPLETE** Home Study Updates for Kinship Caregivers

### **KINSHIP HOME STUDY UPDATE FORM #2**

IMPACTED TEAMS: SAM, Child Welfare, Adoption, and Court or Advocacy Staff

**EXPECTED RESULTS:** May notice the new form is being used when reviewing case information

#### **START: SEPTEMBER 30, 2024**

WHAT: Review new Kinship Home Study Update Form when used

WHO: DCYF SAM, Child Welfare, Adoption, and Court or Advocacy Staff

WHEN: Reviewing the new Home Study Update Form (DCYF 10-018B) when:

- A new kinship child(ren) is added to a licensed kinship home
- Adoption requirements are added for a licensed kinship home
- Converting from unlicensed kinship care to a kinship license, including when adding children

**NOTE**: Kinship Caregivers may notice a more efficient process and will continue to be able to review the resulting report. They will not interact with any new forms or systems.

#### **STOP:** No Change Needed

#### **CONTINUE:**

**WHAT:** Continue reviewing Updates to Home Studies when appropriate.

**WHO:** DCYF SAM, Child Welfare, Adoption, and Court or Advocacy Staff

Frequently Asked Questions	Home Study Update for Kinship Caregivers – CPA & Tribal CPA
What is the Home Study Update Form?	<ul> <li>The new Kinship Home Study Update Form (DCYF 10-018B) is a streamlined version of the existing Home Study Update.</li> <li>The Update is aligned with the new National Kinship Standards and is the basis for developing the new Kinship Home Study.</li> <li>It is a temporary form that will be used until the new Kinship Home Study becomes effective in Summer 2025.</li> </ul>
When should CPA's and Tribal CPA's use the Kinship Home Study Update Form (DCYF 10-018B)?	<ul> <li>Adding a child to a Kinship Care or Kinship License Home Study</li> <li>Adding Adoption requirements to a previously approved HS (without other change of circumstances that would require a new HS)</li> </ul>
Who will complete the new Home Study Update Form and where will they find it?	<ul> <li>The update form will be completed by DCYF Licensing Staff, Child Placing Agencies (CPAs), and Tribal CPAs.</li> <li>The new Home Study Update Form will be available in WA CAP and the Forms Library beginning 9/30/2024.</li> </ul>
How is this new Home Study Update different than the current Home Study Update process?	<ul> <li>Staff and CPA's will continue to assess child safety and follow the procedures for completing a home study update which may include financial, medical, and updated reference checks.</li> <li>Instead of updating the home study, the Home Study Update Form will be completed by staff and CPA's.</li> <li>Caregivers will have an opportunity to review the completed form, much in the same way they do now, and the form will be reviewed and approved by the Supervisor.</li> </ul>
When should the form not be used?	<ul> <li>Community Foster Care Home Study Updates</li> <li>Change in kinship family circumstance requiring a new 3 year license: addition or removal of a caregiver</li> <li>Kinship family wants to provide Community Foster Care</li> </ul>
Can we use the new form for Community Foster Care Home Study Updates?	<ul> <li>No, you must continue to use DCYF 10-043 for non-Kinship Home Study Updates.</li> <li>Changes to the Community Foster Care NRM are underway. A new version of the Home Study may be explored after the FC NRM process is complete, but It is not anticipated changes will be made prior to the new FC rules being finalized (summer 2026).</li> </ul>
Who was involved creating the new Update Form	The workgroup included LD Assessment, SAM, Child Welfare, Tribal Relations, Tribal Partners, WA CAP, Adoption, RESJ, Finance, Workforce Development, Regional Licensing, Tribal and Community Partners, Child Placing Agencies and Tribal Child Placing Agencies. Multiple groups reviewed and provided feedback during the development process.
What if a kinship caregiver leaves the home? Can I use this form to update for the licensed kinship caregiver who stays on the license?	<ul> <li>No, the update form cannot be used for the absence or presence of a caregiver.</li> <li>A new assessment (full home study) and 3-year license is required.</li> </ul>

Frequently Asked Questions	Home Study Update for Kinship Caregivers – CPA & Tribal CPA
What if we have an update already in progress when the new form is released on 9/30/24?	You can switch to the new Kinship Home Study Update Form if it does not impact the overall completion timeline. Any information from the application, or information that has already been entered into the Home Study, will not populate the new Update Form. The unfinished Home Study will remain incomplete.
Can this form be used for Kinship ICPC home study updates?	Yes! The new Kinship Update Form will be used for all Kinship Licenses, including ICPC Kinship Home Study Updates.
Will this form be a "standalone" document or a supplement? For example, do I need to incorporate historical information from prior home studies into this form?	The Kinship Home Study Update Form has been streamlined to reduce duplicative entry for staff. It is a supplement to the original Home Study.
Is this form used if legal action is implemented?	Kinship Home Study Update has the same outcome options and would be used the same way as a Home Study in a legal proceeding
Can this form be resolved as a partial, like the original home study form?	Yes!
Will anything historical auto fill from other forms or sources? If so, what are those?	The form will populate with information from the Application, but no additional historical information from any other sources will be auto populate
