- Review implementation of new child welfare requirements through legislation and caselaw.
- Continue to review DCYF contracting practices (supporting), recruitment and retention of providers.
- Continue the work on concrete supports, services (CIHS, Professional, and Psych), and poverty reduction.
- Continue to Review DCYF policies and practice through a race equity lens.
