#### Announced Monitoring for Certified Tribal CC

- Child Care Monitoring Visits are required annually for all licensed child care programs, per Child Care and Development Fund (CCDF) requirements
- Squaxin Island Outdoor Nature-based program agreement visits will now be scheduled instead of unannounced
- Changing our practice (while Policy 10.1.8 is officially getting updated)
- Draft of our Procedure Guide is attached to the invite



## Procedure Guide for CC Licensing Staff

**Effective immediately,** assigned child care licensing staff will continue required monitoring reviews of the Tribal Programs on tribal lands. Tribal nations on federally recognized tribal lands are legally exempt from licensing; DCYF certifies tribal programs upon request for subsidy payments. These programs are located within federally recognized reservations.

Entry to the programs' sites by DCYF must be requested no sooner than 48 hours in advance (and preferably at least one week in advance), in writing, and at a mutually agreeable time. The written request may be in the form of an email.
