## **Decision Package Description**

The DCYF Leased Facilities Strategic Plan was developed and supports the Office of Financial Management's (OFM) 2023-25Six-Year Facilities Plan as defined by RCW 43.82.055. The DCYF strategic plan incorporates modernization strategies to accommodate increasing space needs while minimizing requests for increased leased space. Modernization requires upfront cost. Most of DCYF' furniture is outdated and not suitable for reconfiguration that would allow for more efficient and productive office layouts while providing appropriate workspace for DCYF staff. DCYF strives to provide employees with a healthy, safe, and suitable work environment. Safety of our employees is necessary to provide quality customer service to our clients. DCYF also has a goal of providing a safe environment for clients who must feel secure when coming to our offices for assistance.

DCYF will consolidate Olympia operations out of five buildings into two. This will allow the reduction of 2 private leases and allow other state agencies to use state owned space on the Capital Campus. The majority of DCYF headquarters operations will be in the 1500 Jefferson building with IT and Imaging operations in the 1310 Jefferson leased space. DCYF will backfill unused DES and WaTech space in 1500 Jefferson located on floor 1 and floor 2. This creates contiguous space for DCYF on both floors. This project reduces space used, lease costs, and improves operational efficiency.
