

# DCYF's New Training Site

## Status Update – June 2023

**Project Summary:** DCYF is implementing a new training site.

- **Child care providers** will be able to find training for in-service hours and complete online trainings on the new site when it launches.
- **Trainers** will access the new site to list trainings, track completions, manage rosters, and connect to their training organization. It's also where new trainers will apply to become state-approved trainers.
- **Training organizations** will be able to submit their curricula for approval, and manage their state-approved trainers in the new training site. - **Conferences and Special Events** will be listed on this site. Organizers will be able to manage sessions and rosters.

- DCYF Professional Development staff attended Provider Supports Subcommittee meeting December 14, 2022 to provide information about DCYF's New Training Site and gather input for engagement planning.
- DCYF Professional Development staff attended the Early Learning Advisory Council (ELAC) meeting on December 6, 2022 to provide information about DCYF's New Training Site and gather input for engagement planning.
- DCYF partnered with DCYF professional development contractors and national training organizations who offer 100 trainings or more each year to import trainings into the new site. DCYF conducted 10 sessions of user-experience (UX) testing with English, Spanish, and Somali-speaking trainers and training organization representatives. Participants provided input that is currently being reviewed to inform training platform customization.

- Through a partnership with the [National Workforce Alliance Registry](http://registryalliance.org) (registryalliance.org), DCYF identified a company called [New World](http://www.newworldnow.com) (https://www.newworldnow.com) with 15 years of specialization in early childhood systems design and development. New World provides a customizable web-based platform called Insight Professional Development and Learning Management System (Insight). Insight is used by 13 other states and was designed specifically to support the needs of the early learning workforce. **New World will customize Insight to serve as DCYF's New Training Site.**

## Coming Up:

- Karma Hugo will present at the ECEAP Directors Check In June 7, 2023 to share an update about DCYF's New Training Site and to collect input for its eventual renaming.
- Between May and July 2023, DCYF will engage with internal and external partners to come up with a new name for DCYF's New Training Site. Though we don't have exact timelines just yet, here's what to expect with our transition to DCYF's New Training Site in 2023:

- Additional UX testing focused on English, Spanish, and Somali-speaking child care providers will be conducted in upcoming months. - Synthesize results of UX testing. Input collected from UX will be utilized to make changes to Insight and create resource materials in preparation for launch.
- How-to guides for:
  - Submitting courses and setting up training events
  - Managing training events, including rosters and evaluations
  - Managing trainers and other staff within a training organization
  - Managing online trainings in the new training site
  - Using the new training site to search and register for trainings on the new site.
- Webinars demonstrating key functions of the new training site
- Open office hours for training orgs and trainer to assist with use of new training site and answer questions
- Individualized technical assistance
- Trainers and training organizations will be notified when it's time to begin transitioning to the new training site.
- Learners continue to use the current training site to access required training until we are ready to transition to DCYF's New Training Site.
