Content Area Focus: Program Planning and Development

The Program Planning and Development competency area focuses on how the early learning professional establishes, implements, evaluates, and analyzes an early care and education setting.

Apply: 2019 is only days away! How can you include the program planning and development competency – focusing on evaluations, strategic planning, and goal setting – in your training for providers? As you use the <u>Core Competencies for Early Care and Education Professionals</u> to develop high quality training, you can also apply this competency in your own reflection and goal setting. As you reflect on 2018 and prepare for 2019, think about:

- How are my trainings providing growth for early learning professionals?
- How do providers implement what they have learned?
- Do I read my evaluations and incorporate feedback into my next training?
- What best practice research am I providing providers to help them evaluate and analyze their own programs?

Read all about it! Now that you have reflected on your training program, check out this <u>article</u>. How can you be like this instructor and use those "absurd" learning opportunities to benefit the professional development of those attending your trainings? The trainings that we provide should be relevant to the audience's work environment and be culturally relevant. What's New

Our online training library, formerly known as deltraining.com has a new name as we transition to the Department of Children, Youth, and Families. All previous training completions and options will still show on the new site – now dcyffraining.com



Here's what's new about our online training:

- 1) The State Approved Trainer Modules are currently unavailable as DCYF updates them. For new trainers, this will not affect their trainer application, and they can move forward in the process without reviewing the modules. When the modules are live, DCYF will send out an update to all trainers letting you know that the modules are available to view (this won't be mandatory).
 - a. New Health and Safety trainings have been added to the online training catalog! Providers won't be required to complete these modules they'll meet the requirement with our updated Child Care Basics. For those who completed Child Care Basics before the update, we developed a

supplemental guide that gives an overview of what's covered in the modules (link). We encourage people to use the modules to know more details. You can find out more about the CCDF health and safety requirements on our website (link).

In October 2018, DCYF released the updated Child Care Basics curriculum that included the federally required health and safety training topics.
