Content Area Focus: Child Growth and Development

The Child Growth and Development competency area builds on the early learning professional's foundational understanding. Child Growth and Development is all about understanding how children acquire language and creative expression and develop physically, cognitively and socially.

Do you take into consideration the key words from the <u>Core</u> <u>Competencies for Early Care and Education Professionals</u>? When writing your learning objectives, try using words like recognize, identify, and explains.
