#### What is IECMHC?

Infant and early childhood mental health consultation (IECMHC) is an intervention that teams a mental health professional with early care and education staff and families. This team works on ways to help promote the social and emotional development of the young children in their care.







# Funding for Tribal IECMHC Project

#### **PROVISO LANGUAGE:**

\$260,000 of the general fund – state appropriation for fiscal year 2023 is provided solely for the department to implement an infant and early childhood mental health consultation initiative to support tribal child care and early learning programs. Funding may be used to provide culturally congruent infant and early childhood mental health supports for tribal child care, tribal early childhood education and assistance program, and tribal head start providers. The department must consult with federally recognized tribes which may include round tables through the Indian policy early learning committee.





# **Project Timeline and Progress**

- Feedback from IPEL meeting in May
- IECMHC program coordinator hired in June, DCYF will continue to expand capacity
- Core Early Achievers team for Tribal IECMHC Project formed in July
- Internal DCYF team development in August
- Tribal group engagement throughout fall (4-6 meetings)


