How to Document Intimate Partner Violence (IPV) Screenings and Referrals in Visit Tracker

Intimate Partner Violence Screening:

What are we measuring?



HVSA Aligned Measure: Percent of primary caregivers enrolled in home visiting who are screened for intimate partner violence (IPV) within 6 months of enrollment using a validated tool.

Instructions: Complete an intimate partner violence screening for primary caregivers using the Relationship Assessment Tool (RAT) form within **6 months of enrollment.**

Data Requirements: Enrollment date, Exit date (if applicable), RAT survey date

How do I enter an intimate partner violence screening into Visit Tracker?

Step 1: Log into Visit Tracker and navigate to the primary caregiver's data page by clicking the "Guardians" link in the horizontal navigation bar, then choosing the primary caregiver's name from the "Select Guardian" drop down menu.

Step 2: Click on the "Assessments" link in the left-hand side menu bar.

Step 4: Complete the Relationship Assessment Tool form, making sure to include the date that the screening occurred, the caregiver screened, and responses to questions 1-10, then click "Create."

If your program has entered IPV screenings using the Futures or WEB form in the past, rest
assured that these screenings have been counted toward the IPV screening aligned measure. We
prefer that programs transition to using the RAT form because it allows you to enter item level
responses, auto-calculates the total score, and includes fields to enter information about referrals,
information shared, and safety planning.

Intimate Partner Violence Referrals:

What are we measuring?



MIECHV Performance Measure: Percent of primary caregivers with positive screens for IPV who receive referral information to IPV resource.

Instructions: If the total RAT score is 20 or higher, the IPV screening is positive, and a referral is needed.

Data Requirements: Enrollment date, Exit date (*if applicable*), RAT date, Positive RAT (y/n), Referral date, Referral Type,

Option 1 (preferred) is to enter a resource connection straight from the RAT form by clicking "Yes" after the question "Was a resource connection made as a result of a concern found during this assessment?"

Step 1: Enter the date the referral was made (not the date the form is being completed) and choose "Intimate Partner Violence" as the referral type. Then click "Create."
