

## Early Achievers Renewal Rating Policy

Early Achievers ratings are good for three years from participants' most recent rating release date. This policy describes the process providers follow to complete their renewal rating.

**What:** Early Achievers Renewal Rating Policy.

**Who:** Early Achievers participants who have an existing Early Achievers rating and have been rated for at least 24 months.

**When:** Twelve months before the third rating anniversary date. Sites must request their first renewal rating on or before their existing anniversary date.

**Why:** Sites must renew their rating every three years and continue to meet Early Start Act rating milestones in order to maintain eligibility for Early Childhood Education and Assistance Program (ECEAP) funding and/or Working Connections Child Care (WCCC) subsidies and tiered reimbursement. Early Achievers scholarships are available to staff at facilities participating in Early Achievers. Additionally, rating status is considered when determining priority for the [Early Achievers Grant](#) and [Washington Scholarships Program](#). A site is considered "participating in Early Achievers" while waiting for renewal.

**How:** Twelve months before the rating anniversary, the Primary Contact or Site Contact/Manager will receive an email reminding them to request their onsite evaluation to renew their rating by completing a Request for On-Site Evaluation application in MERIT. Sites must request their rating before their rating anniversary date in order to maintain their status as a rated Early Achievers participant.

Once the request has been received and reviewed by the state, the Primary Contact or Site Contact/Manager will receive a confirmation email and the request will be sent to Cultivate Learning at the University of Washington. The Community Liaison will then contact the site to discuss the on-site data collection activities.

After data collection has been completed and reviewed for accuracy, the provider will receive their renewal rating. The date the renewal rating is released will become the site's updated rating anniversary date. Providers have 30 days after the rating is released to submit an appeal if they feel their rating is incorrect.

## Early Achievers Renewal Rating Frequently Asked Questions (FAQ)

### How do I request a renewal rating?

You can access and complete the Request for On-Site Evaluation application in MERIT once you are within twelve months of your three-year rating anniversary date.

### What happens if I access the Request for On-Site Evaluation application in MERIT sooner than twelve months from my three-year rating anniversary date?

You will see the option to request either a Free or Paid Re-Rate. Please wait to request your renewal rating until you are within twelve months of your three-year rating anniversary date.

### When I request a re-rate I can choose which areas I want to be rated in (ERS, CLASS and/or records review). Why don't I see these options when I request a renewal rating?

Unlike re-rates, all renewal ratings consist of ERS and CLASS assessments, including new staff and professional development data. Providers that select the full data collection will also receive records review during the on-site evaluation.

### I am an ECEAP program and/or receive state subsidy for non-school age children. What will happen if I do not complete my renewal rating?

Providers who do not complete their renewal rating will be at risk of losing their contracted ECEAP slots and/or state subsidy.

In addition, providers will not be eligible to receive quality improvement awards and tiered subsidy reimbursements.

### What if my renewal rating does not meet the required level for providers receiving state subsidy (Level 3) or ECEAP programs (Level 4)?

Providers who do not meet their required rating level must engage in remedial activities. Information on remedial activities can be found in the [Early Achievers Remedial Activities Policy](#).

Early Achievers participants that provide ECEAP, Head Start services or accept Working Connections Child Care subsidies will be eligible for one free re-rate. Information on re-rating can be found in the [Early Achievers Re-Rate Policy](#).
