Haddii koontada WA Compass ee qofka deeqda codsanaya uusan lahayn lambarka SWV, xaalada codsiga waxay isku badeli doontaa "waxaa wali rahman SWV." Haddii koontada leeyihin lambarka SWV oo aan shaqeyneyn ama aan sax ahayn, xaalada codsiga waxay isku badeli doontaa "waxaa wali rahman SWV" dabadeedna DCYF waxay codsadaha u sheegi doontaa tilmaaha iyo sida loo helo lambarka SWV oo sax ah, shaqeynaayana.

Nidaamka ansixinta guud ahaan wuxuu qaataa 4-6 todobaad. Marka codsiga la ansixiyo loona gudbo lacag bixinta, xaalada codsiga ee WA Compass waxay isku badeli doontaa "Waa la aqbalay," waxaana ogeysiis dheeraad ah loo diri doonaa ka qaybgalaha. Ogeysiisyada waxaa lagu diraa iimayl.

## Helida Lacag bixinta

Deeq helayaashu waxay u heli doonaan lacagaha qaabka xusay tilmaamay diiwaangelinta Helida Lacaga ee Gobolka oo dhan (SWV) 4-6 todobaad gudahood marka la ogglaado kadib. Fadlan ogsoonow in lacag bixinada soo mara nidaamka elektarooniga ah iyo U.S. Postal Service inay qaadan karaa dhowr maalmood oo ah kuwa shaqada, arrintaan oo sameynaysa xiliga saxda ah ee daryeel bixiyaashu helayaan lacagaha.

## Qaybta 5: Kadib Abaalmarinta

Haddii aad hesho Deeqda Baahida Ku saleysan, waa inaad u diyaarsan tahay inaad soo gudbiso risiityada alaabaha iyo kharashaadka aad ku bixisay deeqda lagu siiyay. Marka codsadaha la siiyo lacagaha deeqda ah, dhammaan lacagaha deeqaha ah waa in la isticmaalo hal sano gudaheed oo laga bilaabaayo marka la helay deeqda waana la lagu gato waxyaabaha la oggol yahay oo kaliya.

## Raadraacida Risiityada

Daryeel bixiyaashu waa inay kaydiyaan dhammaan risiityada waxyaabaha ay kusoo iibsadeen Deeqda Baahida ku saleysan muddo dhan todobo sano waxaana laga yaabaa inay DCYF ka codsato inay soo gudbiyaan risiityada. Haddii daryeel bixiye uusan awoodin inuu meel dhigo risiityada waxyaabaha uu iibsaday asagoo isticmaalaaya lacagaha deeqda ah, waxaa laga rabi doonaa inuu qayb ama guud ahaan lacagaha dib ugu celiyo Gobalka Washington

DCYF waxay dooran doontaa tusmo bakhtiya-nasiib ah oo deeq bixiyaal si ay u soo gudbiyaan risiityada dhammaan waxyaabaha ay ku iibsadeen deeqda. Daryeel bixiyaasha risiityadooda dib loo eegaayo waxaa la ogeysiin doonaa hal-sano kadib marka muddada ay lacagta ku isticmaalayaan xirmato.

DCYF waxay aqoonsataa dhowr qaab oo ay ku eegayso dhammaan risiityada lacagaha deeqda ah. Hoos waxaa lagu qoran fikrado ku saabsan sida loo bilaabo:

- Hayso dhamaan risiityada.** Qodobkan lama buunbuunin kari. Sameysashada nidaam haboon ood ku kaydsanayso risiityada wuxuu kuu kaydin karaa wakhti badan haddii aad kamid noqoto dadka risiityadooda dib loo eegaayo.
- Iskaan garee risiityada oo hayso ugu yaraan shan sano.** Arrintaan waxay noqonaysaa muhiim haddii khada risiityada baaba'do. Haddii DCYF aysan akhrin karin risiitka, ma awoodi doonaan inay aqbalaan marka ay risiityada dib u eegayaan. DCYF waa ay aqbashaa in risiityada nidaam elektaroonig ah lagu kaydiyo. Hase yeeshee, waa fikrad wanaagsan inaad meel hoose ku kaydiso risiityada maadaama aaladaada kaydka ay halaabi karto.
- Risiitka sawir oga qaad taleefoonkaaga.** Kani waa fikir wanaagsan waxaana jira ablikeeshino aad u fiican oo kaa caawin kara arrintaan. Marka la eego teknoolajiyada maanta jirta, waxaad "kaydin kartaa xogta risiityada dabadeedna waxaad ka qaadi kartaa sawir." Laakiin xasuusnoow inaad kaydsataa faylasha barnaamijka abk.

4. **Ogoloow in risiityadaada laguugu soo diro iimayl, haddii lagu soo bandhigo.** Kani waa fikir wanaagsan, dad badan oo wax iibiya ayaa kusoo bandhigaaya adeeggaan.
5. **Haku tiirsanaan bayaanka bankiga, bayaanada kaarka lacagta cadaanka ah, ama jeegaga la baajiyay.** Kuwaan waa muhiim, laakiin kuma filna cadeyn haddii aadan hayn risiityada saxda ah. Diiwaanka kaydka sababo la xariira, bayaanada baanka, bayaanada kaarka lacagta caddaanka ah, jeegaga la buriyay waa wax wanaagsan, laakiin xogta lacagaha, ee lagu qoro risiityada, waxay muhiim u yihiin dib u eegista risiitka ee DCYF. DCYF waxay arki kartaa bayaanka kaarka lacagta cadaanka ah oo muujinaaya inaad \$435 kala baxday Home Depot, laakiin wax fikrad ah kama haystaan wax saxda ah ee aad gadatay. Waxay noqon kartaa inaad gadatay mashiinka hilibka digaaga lagu shiilo halkii aad ka gadan lahayd biraha lagu kutubo ee lagu iibsano karo deeqda sida ku xusan Xeerka Dadka Naafada ah ee Mareykanka (Americans with Disabilities Act, ADA).
6. **Wax haku gadan Lacag Caddaan ah.** Arrintaan aad ayay muhiim u tahay. Lacagta caddaanka ah waa ay adag tahay in la oggaado, waxaana fudud inay si fudud ku baxdo, waana aad u adag in lagu qoro risiit. Isticmaal kaararka deynta iyo lacagta caddaanka ah; waxay ku siinayaan bayaano bille ah waa si fudud loona barbardhigi karo risiityadaada.
7. **Dalbo caawimaad haddii aad u baahan tahay.** Nidaamka dib u eegista risiitka ujeedadiisu ma ahan in lagaaga bajiyo. Fadlan waydii haddii aad qabto wax su'aalo oo ku saabsan noocyada risiityada iyo dukumiintiyada lagaaga baahan karo. Halkan waxaan u joognaa inaan ku caawino.

Fadlan ogsoonow in DCYF isticmaasho tirada boqolkiiba degmo dugsiyeedka dhan, ee aysan dugsi si gaar ah u eegin.




