Decision Package Description

Foster Parent Application Portal

During the 2019 – 2021 Biennium, the legislature approved funding for DCYF to develop a provider portal that would allow foster parents, unlicensed caregivers, group care facilities, and child placing agencies (CPA) to enter and maintain information during the initial licensing and home study processes. However, due to the pandemic and issues with hiring and retention of IT personnel, DCYF was not able to complete the project prior to the end of the biennium on June 20, 2021. DCYF requests that the balance of the IT Gated Pool funding of \$1,190,000 be transferred to Fiscal Year (FY)22 to enable DCYF to complete this project.

Mandatory Reporters Online Portal

During the 2020 Legislative Session, SB 6556 was passed requiring DCYF to establish, develop, and implement a web-based reporting portal accessible to mandated reporters for reporting child abuse and neglect as required by RCW 26.44.030. However, due to the pandemic and issues with hiring and retention of IT personnel, DCYF was not able to complete the project prior to the end of the biennium on June 20, 2021. DCYF requests that the full balance of the IT Gated Pool funding of \$281,000 be transferred to FY22 to enable DCYF to complete this project.
