PDG is a federal grant available to states and territories to support early childhood services for children birth to age five. Funds support a needs assessment, strategic planning, family engagement, quality improvement, workforce compensation and supports, and direct services for young children.

Where We've Been & Where We're Headed


- 2018 DCYF awarded an initial grant of \$5.3M
- 2019 DCYF awarded renewal grant for \$33.5M to carry out approved activities over the next three years.
- 2023 DCYF awarded Planning Grant for \$4M
- 2024 and beyond DCYF anticipates another renewal grant
