Purpose

The purpose of this memo is to provide guidance to Child Welfare Division (CWD) and Licensing Division (LD) employees on the new requirements from Senate Bills (SB) 6006 and 5453, which:

- Expands the definition of "abuse or neglect" and "dependent child" in RCW 26.44.020.
- Requires a validated assessment tool be used for reports of sex trafficking, severe forms of trafficking in persons, and sexual exploitation.
- Gives the department the authority to file petitions for ex parte temporary sexual assault protection orders on behalf of children or youth.

The rules, policies, procedures, and FamLink are in the process of being updated. This memo and the emergency rule are effective July 1, 2025. All other requirements within these policies and rules remain in effect.

New Requirements

RCW and WAC

The following changes to RCW and WAC impact the policies below:

- The definition for abuse or neglect has changed in RCW 26.44.020 and now includes:
 - Female genital mutilation (FGM)
 - Sex trafficking
 - Severe forms of trafficking
- <u>WAC 110-30-0030</u> Child Abuse and Neglect has been retitled "Abuse or Neglect of Children and Youth," and has been updated to include the following definitions:
 - FGM to the subsections of "physical abuse" and "negligent treatment or maltreatment."
 - Sex trafficking and severe forms of trafficking, also known as labor trafficking.

Policy

Commercially Sexually Exploited Children (CSEC) Policy

Caseworkers and LD workers must contact DCYF Intake immediately and make a report if there is suspicion or prior indication that children or youth have been victims of sex trafficking, severe forms of trafficking in persons, or sexual exploitation as defined in WAC 110-30-0030 Abuse or Neglect of Children and Youth.

Caseworkers may file petitions for ex parte temporary sexual assault protection orders, which are issued without prior notice to respondents, on behalf of children or youth if needed, when:

- There is an allegation of commercial sexual exploitation by the referrer.
- They believe children or youth lack the ability or capacity to consent.

Human trafficking screening and missing from care employees or designees must complete the validated assessment tool when assigned.

Intake Process and Response Policy

Intake workers must follow the <u>Intake Training Manual</u> when screening in allegations of FGM, sex trafficking, and severe forms of trafficking for children and youth.

Dependency Petition Process Policy

When it has been determined court intervention is necessary to prevent harm to children's or youth's health, safety, or well-being, caseworkers must:

- File dependency petitions when children or youth are victims of sex trafficking or severe
 forms of trafficking in persons under the <u>Trafficking Victims Protection Act of 2000, 22</u>
 <u>U.S.C. Sec. 7101 et seq.</u> and parents or guardians meet one or more of the following
 criteria, they:
 - Were involved in the trafficking.
 - Facilitated the trafficking.

- o Should have known that their children or youth are being trafficked.
- Recommend out-of-home placement in dependency petitions when it's determined necessary to prevent imminent physical harm to them due to FGM, sex trafficking, or severe forms of trafficking.
