SUBJECT: **JULY 2010 POLICY AND UPDATES IMPLEMENTATION**

The Children's Administration (CA) July 2010 in person Policy Roll-Out Training is about to begin. You received information on the legislative items with impact on CA in the memo dated June 4th. These legislative impacts went into effect June 10th. The July in person training will provide you with more details on these legislative items as well as supporting documents.
