Full Council Meeting Minutes Thursday, December 5, 2024 3:00 – 5:00 PM

JR Overcrowding & DCYF Response: Lauren Knoth-Peterson, OFM

- Provided high level overview of JR facilities and Community Facilities and their populations including sentencing guidelines (juvenile & adult) and security classifications along the continuum of care
- Current populations:
 - Green Hill School 235
 - Echo Glen CC 113
- As of October, 16 youth with adult sentences at GHS have an earned release date between ages 25-26 and are potentially eligible for CTS

Juvenile Rehabilitation Updates: Felice Upton & Jenny Heddin, DCYF

- Provided overview of recent legislative changes around JR as well as recent challenge areas
- 60% staffing turnover during COVID-19
- GHS has been above Safe Operational Capacity since July 2023
- Current goal to reduce capacity to 180 with best practice recommendation of 150
- Overview of assessment processes used within JR
 - Moved to risk/need/responsivity model in 2023
 - Dynamic risk v. static risk allowing for change/growth
 - In 2025 moving toward taking clinical staff off of the unit floor
- DCYF Funding Requests for 2025 Legislative Session
 - Mental Health and Wellbeing

- Therapeutic Staffing and Processes
- Emerging Adult Leadership Program at Stafford Creek
 - 6-month program
 - 48 young men aged 18+ with preference for 21 and older
 - Have received HS Diploma or GED
 - Medium security classification
 - Stable mental health and no significant ongoing medical needs

OJJDP 2024 National Conference Reflections:

- Highlighted the need for change in Medicaid law
- Proximal understanding during the change making process
- Appreciation shared for the opportunity to gather with others doing similar work around the country
- Grateful for opportunities to uplift young people and their voices

Public Comment

Sara Zier, Team Child – Highlighted the need for additional time/space for people with different experiences with the system to share their viewpoints outside of the data that was presented. Requested that the Council think of the Stafford Creek Facility as a temporary step, and to begin putting in place processed to unwind the presence of JR on a DOC facility. Also requested that the Council advocate for more youth and family involvement in developing solutions.

Roxana Gomez, Legal Counsel for Youth and Children – How can DCYF guarantee that only DCYF staff will be handling and interacting with JR youth at Stafford Creek? Requested time for advocates and community members to have their questions about the facility answered as well as discuss alternative solutions to reduce JR population.
