Ew an FVS goal an epwe anisi famini ar repwe fiti ekewe aninisin famini nge pwan epechekunen an famini repwe nomw fengen.

Caseworkers wiser repwe anisi ekewe famini repwe enukufengenir, anisir, me tumwunun ewe semirit. Ekewe famini iir mi pwan tongeni fini ined resapw chiwe angang ngeni ewe Department of Children, Youth, and Families (Ofesin ren Semirit, Eonuwen, me Family, DCYF) ined chok ra mochen. EXPECTATIONS

Met kopwe expect seni noum ewe FVS caseworker

- Ina repwe sufonituk me om famini.
- Ina repwe angang ngonuk me fori ekewe sokopaten aninisin an epwe tumwun noum kewe me wor metekewe iir mi need.
- Ina repwe pwan awora ekoch annis ngonuk me om famini, chowean sukunen nonomwun om famini, counseling; ika aninisin safei. Nò ngeni ewe DCYF website ren om kopwe kuna kewe sokopaten aninis me pisekisekin.
- Ina repwe churuk me om famini me noum kewe non mwonomwon imwemi we fan 2 non ew maram.
- Ina repwe kokori kewe chon awora kewe aninis, community partners, famini me chiechiomw (fan chok om mwumwuta) ar repwe sinei porousomw me om famini.
- Repwe fos ngonuk usun tumunun inisumw me tumunun semirit/semirit.
